Bullying behavior creates feelings of defenselessness and injustice in the target and undermines an individual's right to dignity at work. In a recent study of U.S. workers, 41.4% of respondents reported experiencing psychological aggression at work in the past year. This represents 47 million U.S. workers. (*Schat, Frone & Kelloway*)
